EARLY CHILDHOOD EDUCATION

GIVING CHILDREN A STRONG START

We all benefit when every child from the earliest age has a strong developmental start. RCUW funds programs that improve developmental opportunities for lower-income, at-risk children. We seek to address the following challenges:

- Access to affordable, quality preschool and childcare
- Access to other early childhood development programs that promote literacy, kindergarten preparation or parenting skills
- Childhood food insecurity
- Childhood mental health
- Need for more and better qualified preschool teachers

EARLY CHILDHOOD EDUCATION FACTS

- At any given time there are only 40 slots for infant child center care in Routt County for approximately 450 babies. (Family Development Center)
- 90 to 100% chance of developmental delays when children experience 5 to 6 risk factors. (Center on the Developing Child, Harvard University)

ROUTT COUNTY UNITED WAY SUCCESSES

- RCUW has provided \$1.2 million to early childhood education since 2000
- 97% of 4 year-olds in Routt County who are attending early learning programs are ready for Kindergarten (First Impressions of Routt County)

A two-parent household with two preschool age children were like many families struggling to make ends meet. Then the father was diagnosed with some physical and mental illnesses. He lost his ability to drive or help to take care of his children. The family went from two incomes to one, and now has additional stressors. Discovery Learning Center was able to offer the family a substantial Routt County United Way scholarship so that both children are able to attend schooling five days per week. Both children were developmentally younger than their chronological age when they began preschool, but after a year of attendance, both children have caught up to their peers.

YOUTH SUCCESS

PROVIDING YOUTH A SAFE, HEALTHY, NURTURING ENVIRONMENT

Transitions are sometimes tough for young people, particularly at-risk youth. RCUW seeks to fund programs and initiatives that will support the successful transition of elementary school students into middle school, of middle school students into high school and of high school students into adulthood. Challenges that we will look to address are:

- Literacy at grade level
- Financial literacy or work/life readiness
- Food insecurity
- Mental health support and suicide prevention
- Bullying prevention and support for diversity
- Access to alcohol, tobacco, vaping and other drugs
- Need for student engagement and/or parental support
- Healthy behavioral boundaries
- Appropriate use of technology

YOUTH FACTS

- 68% of Routt County High School students admit to have used alcohol (2017 Health Kids Colorado Survey, Routt County Report)
- 21% of those living in Northwest Colorado believe that drugs can help manage teen stress (2018 Rise Above Colorado Youth Survey)
- Youth that are involved in extracurricular activities including service and civic engagement are less likely to engage in risky behaviors. 52% of youth reported to be involved in one or two extracurricular activities (2018 Rise Above Colorado Youth Survey)

ROUTT COUNTY UNITED WAY SUCCESSES

- RCUW programs touches 70% of the youth in Routt County
- Provide additional opportunities for youth to be engaged: Boys & Girls Club, Partners of Routt County, Rocky Mountain Youth Corps to name a few.

FINANCIAL STABILITY

IMPROVE THE FINANCIAL STABILITY OF ALL RESIDENTS IN NEED

With 30% of Routt County households living below the county self-sufficiency standard, many individuals and families struggle to make ends meet. Lack of savings or insurance may make other adults or families vulnerable to unanticipated, adverse circumstances. Financial self-sufficiency may be difficult to achieve or maintain for people who have poor mental health or who experience physical or emotional abuse. Programs that seek to achieve the following will be considered:

- Build financial skills and social/emotional resiliency through adult education or counselling in such areas as household financial management, mental health and well-being, suicide prevention, family relationships, or workplace readiness
- Reduce food insecurity
- Enable seniors to live in their homes longer if they wish
- Prevent domestic violence or abuse
- Improve family stability

FINANCIAL STABILITY FACTS

- 1 in 3 households fall under the self-sufficiency wage standard in Routt County. A family with two adults and no school-age children would need to earn \$78,755 per year to cover basic expenses in Routt county, more than \$50,000 above the federal poverty bench march for a family of four (Colorado Center on Law and Policy)
- 77% of families with children under the age of 6 have both parents in the workforce (First Impressions)

ROUTT COUNTY UNITED WAY SUCCESSES

- In 2020, our partnership with FamilyWize saved 83 individuals over \$6,800 in prescription costs
- When 84 Routt County residents didn't know where to turn, they called the 2-1-1 hotline for 24/7 free and confidential human service referrals

Jane is more than 90-years old and has been receiving Meals on Wheels lunches four days a week for close to five years.
